

**PET AGREEMENT**  
(Addendum To Vacation Rental Agreement)

Guest hereby agrees to the following further restrictions and guidelines:

1. Failure to comply with these restrictions and guidelines may result in a fine of not less than \$150 per occurrence or the actual cost of the damages: which Guest authorizes Agent to charge to their credit card on file in the event of a violation.
2. The only pet acceptable at said property are small dogs.
3. No puppies or kittens shall be allowed.
4. All pets are to be licensed and vaccinated according to your local jurisdiction.
5. All pets are subject to local noise ordinances and shall not disturb other resident neighbors.
6. Pet owners (Guest) shall clean up after their animal inside **and** outside at all times. Guest understands that animal wastes are a danger to health and sanitation.
7. If any excrement is found Guest may be fined \$150 and be charged an additional fee for cleanup.
8. Guest agrees to pay for the cleaning and/or repair of stains or markings on any surface caused by the pet.

Guest hereby agrees to pay an additional pet fee as advertised on [www.LakeM.com](http://www.LakeM.com) which is non-refundable.

Landlord/Agent shall not be liable for any damage to person or property caused by the pet and Guest hereby agrees to hold Landlord and Agent harmless from such liability.
